- I have familiarized myself with the basic information about Big Bear's Ultra 2023 race (further "Race") and other information and recommendations from the organizers of the Race published on the website www.bigbearsultra.sk and I was also provided information by the organizers of the Race through the information e-mails.
- I have read the Race Rules published on the www.bigbearsultra.sk website and I undertake to abide by the rules throughout the duration of the Race.
- I have become familiar with the route of the Race, information about which is published on the website www.bigbearsultra.sk.
- I am informed about the nature, course and other conditions of the Race.
- I am not aware of any obstacle in my health, physical state and mental state that would prevent me from my participation in the Race or endangered my safety for the duration of the Race.
- I am not aware of any obstacle in my health, physical state and mental state that would endanger other participants in the Race (I have no infectious disease tonsillitis, flu, Covid, etc.).
- that I am sufficiently prepared for this Race and that I am aware of the risks arising from participation in the Race of this nature.
- I am aware of the recommendation of the Race organizer: to undergo an individual medical check-up before the Race, especially if I have recovered from an infectious disease (tonsillitis, flu, etc.) within a period of time the last 6 to 8 weeks before the start of the Race.
- I participate in the Race of my own will and at my own risk. I accept that the organizer of the Race is not responsible for any personal injury caused to me during the duration of this Race. I take on knowing and accepting that I am not entitled to claim financial compensation from the Race Organizer, or make any other claims in the event of an injury sustained by me during the duration of this Race. I declare that I am aware of the responsibilities and risks associated with my participation in the Race.
- the organizer of the Race is not responsible for any of my actions that would be contrary with information about the Race listed on the www.bigbearsultra.sk website or which would be contrary to the Rules of this Race or contrary to the instructions of the organizer of this Race authorized persons (especially volunteers and paramedics working at the Race).
- the organizer of the Race is not liable for any health or property damage caused by me during the duration of this Race to the third parties.

- I am aware that no special insurance has been taken out by the organizers of the Race to cover damage that the participant could incur in connection with participation in the Race
- I acknowledge that in the event of an accident the medical services of the Race organizer are provided only at certain first aid station(s). The Race organizer, the volunteers and especially medical professionals working at this Race, have in In order to protect the health of the participants in this race, the right to stop a participant who shows signs of excessive exhaustion and or who poses a fundamental danger to his safety, health or life. In the case of health complications that could endanger the safety, health or life of the Race participant, Race organizer have the right to decide on termination of his/her participation in the Race or its interruption for the necessary time.
- I am aware that the organizer of the Race reserves the right to change the route and program of this Race, including the interruption, early termination or cancellation of this Race, mainly to ensure the safety of Race participants. In the event of such a change of route, interruption of the Race, premature termination or cancellation of the Race, the participants of the Race are not entitled to a refund of the entry fee or parts of it.
- I am aware that the organizer of the Race is responsible for the permission to use the space designated to organize the Race mainly the starting point, the check points, the finish and the route of the Race. However, the organizer is not responsible nor gives a guarantee for the condition of the Race route, caused for example, by weather or other unpredictable circumstances (the organizer is not responsible for the weather conditions at the time of the race).
- I undertake to follow all instructions from the organizer of the Race as well as instructions from volunteers, and from medical professionals working at this Race for the entire duration of the Race.
- I undertake to carry with me for the duration of the Race complete mandatory equipment specified in the Rules on website www.bigbearsultra.sk, of which I was also informed via informational e-mail.
- I am aware that in case of missing mandatory equipment at any stage of the race, I can be disqualified without the right to a refund of the entry fee. At the same time, I am aware that I will be responsible for all costs that may arise due to the lack of mandatory equipment, for example missing or insufficient insurance in the event of rescue by the Mountain Rescue Service
- I am aware that I am obliged to comply with the legislation of the Slovak Republic, namely Act No. 543/2002 on Protection nature and landscape.
- I will obey traffic laws and increase my caution where the route of the Race passes through roads with traffic.
- I agree that my participation in the Race will be recorded in audiovisual form by the Race organizer or persons authorised by him (in particular volunteers, photographers, videographers), agreeing that recordings or photographs made before, during and after the Race have been used at the venue by the organizer of the Race or persons authorized by him for the purpose of promoting the Race, without the right of the reward to the Race participant.
